This will be accomplished by providing a structured forum for sharing valuable knowledge, finding common solutions, identifying resources to achieve improved health outcomes, improved quality and patient experience of care, and lower costs for all Idahoans.

	<p>This was a brief special meeting convened to decide if we will apply for the available RC grant, and if so, what project to pursue. After discussing the options listed, it was decided that we will apply for funds to address suicide prevention in our region. We have a three-pronged plan for our grant application.</p> <ol style="list-style-type: none"> 1. Hold a suicide prevention conference in September of 2017 to coincide with National Suicide Prevention Month. 2. Promote the regional use of the Columbia Suicide Severity Rating Scale (C-SSRS) within several disciplines (health care providers, behavioral health providers, school systems, law enforcement, etc.) so that community members get consistent messages from those from whom they seek help. 3. Promote Project Childsafe among all law enforcement agencies in our district. Project Childsafe is a program sponsored by the National Sports Shooting Association that distributes cable gun locks and educational materials to law enforcement agencies. Law enforcement agencies distribute the free locks to the public via safety fairs or by individual request. <p>We will seek a partnership with the Regional Behavioral Health Board, with whom we have close ties, for this project. They are interested in promoting regional use of the C-SSRS and may be able to provide additional expertise and support. We will also seek coordinate with the Suicide Prevention Action Network (SPAN) Idaho program to avoid duplication of services and tie our work into National Suicide Prevention Week in September, 2017.</p>
