Action Item -Crisis		
Matt Hardin & Myrna Daniels	Matt Hardin; director of the crisis center gave update of the crisis center that has been open since April 2019. The center is for adults and is open 24 hour a day, seven days a week. There are 20 beds and three per day served for clients. Matt described that a crisis is can be either mental health or substance use/ misuse crisis. The crisis center is not equipped to serve those that need a medical detox. The center is all voluntary, which is a safe environment while a person in crisis to get to the primary care and stabilize. The may be referred to hospital, but only 1-2 times weekly which reduces the strain on the hospital resources. The crisis center is all about treatment, if any unused drug or paraphernalia goes into an amnesty box (secured lock box) for police officers to pick up and dispose of. The Crisis center is state funded and does bill Medicaid if the client has it. There is security and 4 staff at all times. Matt gave brief overview of the staff positions and their tasks within the crisis center programming. He went through the screening/assessments, motivational interviewing, treatment plan, case management skills used for a client stay. Various questions were answered from board members, Discussion on the proximity of the liquor store to the crisis center, staff trainings of crisis center staff, created atmosphere of dignity and humanity toward clientele and community outreach for teens. Brochures were left for the members about the Crisis center. Matt spoke of the "Rise Up" youth and teens crisis center in Idaho Falls.

Action Item- Sub-Committee Updates

CMH Subcommittee- Victoria reported that the focus of the CMH committee is the upcoming Children's Mental Health Wellness Wiggle event set for Saturday, May 20, 2023. She gave an overview of the happenings and promotion of the event.

Member Updates/Announcements:

Charlie Aasand reports that the hospital census is up, as there seems to be more people needing services. For the BH unit there has not been a need for access travel nurses. Seeing more stabilization within the medical staffing.

Jason Dye updated the members of the treatment courts compacity and transition from the ACT team to private providers for mental health court. There is a need for providers, which would contract with the DHW. There will be an upcoming Juvenile SIMS mapping on July 21

Michelle LaRock updated the members of the Family Night program that is being put on through Center for Hope South. Applications are being taken through August 11, 2023.

Chessie Meyer- That the PFS grant is not being renewed. Many of the primary prevention strategies that have been presented to the board will are looking for ways to sustain the activity. She went on to briefly described the "Take the Reins" program as an equine lead curriculum combined with an evidence-based life skills program.

Victoria Byrd encouraged board members of to take the free QPR training for suicide prevention. It is virtual and is only an hour long.

Terry Fredrickson- Mentioned the comfort of being able to counsel without having some COVID nuance involved, getting back to more personable. Also reminded the members of the lack of understanding of the opioid crisis that is happening within our community.
